- Do you need to transfer sensitive information from one location to another within your country or between countries? Do you fear this information reaching the wrong hands, being intercepted by a third party or duplicated during the transfer?
- Does your information need to pass all existing security products on the market (Firewalls, Intrusion Detection Systems, Incoming & Outgoing info monitoring tools etc.), and will be able to enter a secured network or exit a secured network without being detected or raise suspicion?

**The VIPER system is the ideal solution to these needs and others!**

## **VIPER 1.0 – More Information (A)**

- ▶ VIPER was developed by Mr. Itzhaki-Weinberger, a senior technologist. Mr. Itzhaki-Weinberger is an expert in data security who was an officer and chief technologist in Israel's elite technological intelligence unit!
- ▶ VIPER is based on a unique idea & algorithm, and is the product of the investment of many resources and knowledge. VIPER is the best "last line of defense" system on the global market today!
- ▶ VIPER makes your sensitive information "vanish", making it totally unavailable.
- ▶ VIPER is ideal as your "last line of defense":

For example, Lets take an extreme situation where the computer storing your sensitive information falls into the wrong hands, despite other security measures you took. Such measures can be total disconnection from the internet, the use of firewalls and other security products, using encryption, preventing physical access to the computer to unauthorized personnel and other means. Even in such an extreme situation, your information will be inaccessible and invisible, protected by VIPER.

Another example:

You are transferring sensitive information on a Diskette / CD from place to place using a courier.

You fear that a third party will manage to get access to the Diskette / CD while in transit.

Also, you may not want the courier himself to see the insides of his delivery, or have the possibility to duplicate it and sell it to a third party etc.

Even in such a case, where the Diskette / CD or its content fall into the wrong hands, the sensitive information itself will still be protected and not visible, again by VIPER.

## **VIPER 1.0 – More Information (B)**

- ▶ You may protect almost anything by using VIPER. The information protected by VIPER can include many types of data, such as: Commercial secrets, Names & Phone numbers, Details needed to coordinate an action, Orders of any sort, Photos of people or structures, Tables and charts, Codes of safe deposit boxes or bank account numbers, The location / coordinates of goods / info / pickup points, and almost anything else – all protected easily by VIPER.
- ▶ Your information will be protected and undetectable by any existing software on the market, even if the third party hires security and IT experts.
- ▶ VIPER can also be your front defense line:
  - In many cases, the protection VIPER supplies is strong enough to be your front defense line, not only your last.
  - VIPER makes your sensitive information invisible, allowing you to cut your security budget, while assuming that **even if a third party develops access to the media storing your information, they will not have the ability to access it or trace it.**
- ▶ Your information will become available again only after passing an UnVIPER process, accessible only to you.
- ▶ VIPER also includes an installation module and a "self-destruction" module.
  - These modules allow you to install VIPER on a computer, protect your sensitive information, and immediately afterwards remove VIPER from your system, without leaving any trace that it was installed on the system.
  - This is a unique quality of VIPER – many software products, especially under "Windows" operating system, leave many undesirable traces even after their removal.

## **VIPER 1.0 – More Information (C)**

► **And to sum it all up:**

**VIPER can save you much damage caused by the exposure of your sensitive information – from millions of dollars-worth of financial damage, to any other damage that can be caused to you by the revelation of undesired information you have.**

**This protection is given whether you protect commercial secrets or any other type of secret, whether the information is located on a computer secured by other means or a completely defenseless system.**

**This protection is given to immobile information and also to mobile information – transferred by a courier on a CD or Diskette or any other means, or even sent on a regular e-mail message.**

**The protection VIPER supplies is good against a broad number of threats, and can be used for various needs.**

These experts used their unique knowledge and many tools in their attempt to find the information – tools available on the free market, & some unique ones developed by the experts.
